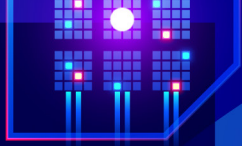

YOUNG INDUSTRIALIST AWARDS OF HONG KONG 2026



宗旨·OBJECTIVES

「香港青年工業家獎」為香港工業總會（工總）的年度盛事，於1988年首次舉辦，旨在表彰成就超卓、對香港經濟及社會發展有傑出貢獻的年輕工業家，從而啟發更多青年才俊投身工業，實踐和發揚香港工業追求卓越的精神。

The “Young Industrialist Awards of Hong Kong” has been an annual flagship event of the Federation of Hong Kong Industries (FHKI) since its inception in 1988. It aims to honour outstanding young industrialists with significant achievements and commendable contributions to the economic and social development of Hong Kong, as role model to inspire the next generation and arouse their dedication to industry and pursuit of excellence.

參選資格·ELIGIBILITY

候選人須符合下列各項資格：

- (一) 截至2026年5月15日止，年滿21歲又未足46歲（即1980年5月16日或以後出生）；
- (二) 持有香港身份證；
- (三) 服務機構為香港註冊的公司，並主要從事工業。除涉及物品或零件的製造、改造、裝飾、整理、加工、包裝或整形等工序以供銷售的傳統製造業外，新興產業如新能源，及創意產業亦可參選，惟其業務必須包含研究開發、人工智能、專利等技術元素；及
- (四) 經個人或機構提名。

To be eligible, a candidate must be:

1. Aged between 21 and 45 on or before 15 May 2026 (i.e. born on or after 16 May 1980);
2. Holder of Hong Kong Identity Card;
3. Working for a Hong Kong-registered company principally engaging in industrial activities. In addition to traditional manufacturing industries which consist of the manufacture, alteration, ornamentation, finishing, processing, packaging or transformation of articles or parts of articles for sale, emerging industries such as new energy, and creative industries are also eligible to apply, provided that its business incorporates technological elements such as R&D, AI, patents, etc; and
4. Nominated by an individual or an organisation.

評審準則·JUDGING CRITERIA

評審委員會將由工總邀請具威望的社會賢達及資深工業家組成，按候選人的成就、遠見、貢獻及誠信挑選得獎人。

The FHKI will form a reputable judging panel comprising prominent public figures and leaders of industry to select awardees based on the achievements, vision, contributions and integrity of candidates.

Committed to industry and advancing its progression, dedicated to community service and corporate social responsibility, and contribute to the betterment of Hong Kong.

Honorable and with respectable personal integrity and business ethics.

No age limit to the nominees, but the nominee must be Hong Kong residents and actively engaged in industry. Members of the judging panel and employees of the organiser are not eligible to nominate or to be nominated.

Selection is selected based on nominee's contributions to the Hong Kong industry and community, along with a proven record of achievement.

特別是候選人及其領導的公司在專業領域內取得的成就、對香港工業和社會的影響，及在慈善和企業社會責任等方面的付出。

Especially the outstanding achievements in the professional field and his / her company's contribution to Hong Kong industries, as well as their company's contribution to Hong Kong industries and community, including charity and corporate social responsibility areas.

Each nomination must be submitted in the prescribed form endorsed by both the nominator and the nominee by online system / email / post, together with supporting documents and application fee to the FHKI by the nomination deadline.

Members of the judging panel and employees of the organiser are not eligible to nominate or to be nominated.

Nominators may submit as many nominations as they wish. Separate nomination forms should be used for each nominee.

However, each candidate should only accept nominations from a single nominator. If the organiser receives more than one nomination for the candidate, the first completed nomination form submitted to the organiser will be deemed the candidate's valid nominee. Subsequent nominations will not be considered.

Each Industrialist of the Year Award nominator should submit supplementary materials such as annual report, multimedia interview, press article, autobiography and any other pertinent documents showcasing the nominee's significant impact and accomplishment on or before 14 June 2026, to provide the Judging Panel with a more comprehensive understanding of the candidates. Any late submissions will not be considered.

Information submitted by the nominator and nominee will be taken into account by the screening committee and the judging panel when assessing the merits of the nominee. Providing as many details as possible would facilitate the judging process.

All information submitted will be kept strictly confidential except for evaluation by the screening committee and the judging panel. Appropriate information will only be released if an award is granted. The organiser retains all rights to modify the Award's rules and criteria at its sole discretion. In case of any disputes, all decisions made by FHKI shall be regarded as final.

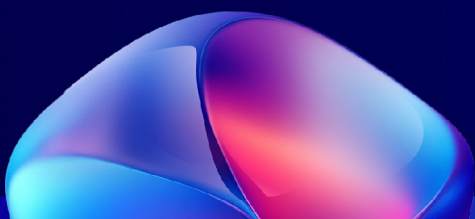
